The study presented in the paper is trying to surface the issues of international trade, policies of which are guided by the market forces and international relationship. Both bilateral and multilateral trades put forth some opportunities and issues as well. The most vulnerable stakeholders come from developing countries. They are impacted negatively by global trade policies encompassing tariffs, quotas and trade agreements. The developing countries are characterised by low-income levels, less industrialisation and higher dependence on agriculture. For achieving climate resilience, it is necessary to reduce the trade risks. However, volatile global market has posed significant challenges according to the authors. The study has given the case study of South Korea exhibiting the success story how integrated approach of investing in education and achieving innovations in electronics have made the country a leading exporter of electronic goods. For comparative analysis the study has chosen the case study of struggling economy of Malwai. It has encountered significant hurdles, such as limited infrastructure, dependency on a narrow range of exports and difficulties in meeting international standards. The country's reliance on tobacco exports makes it highly vulnerable to fluctuations in global demand and prices, leading to economic instability and slow growth. Thus, the paper concludes that global trade policies have significant and varied impacts on developing economies. While they can provide opportunities for growth, innovation, and employment, they also pose risks related to market volatility, deindustrialization and trade imbalances. The paper urges that future global trade policies should involve regional cooperation and focus on sustainable development. The paper also warns that developing countries have to face the situations created due to challenging trade liberalization.

"Infrared Spectroscopical Analysis of Some Metamorphic (Granite) Rocks"

The investigator has adopted scientific approach right from selection and collection of samples to use of infrared spectroscopic method. The selected rock samples are granite. The mineral characters of metamorphic rocks are tremolite, kyanite, stautolite, talc, serpentine, mica and chlorite. Infrared spectroscopy is one of the foremost capable explanatory strategies which offer chemical distinguishing proof and is a powerful tool in identifying quantitative and qualitative analysis of the minerals present in geological samples. The experiment has indicated the presence of quartz, feldspar, diapside, garnet and chlorite minerals. The obtained results are tabulated and interpreted in light of available literature with special reference to crystallinity index, absorbance and extinction coefficient.
